1. The Tournament will be conducted as a "Baker Scratch Tournament." This Tournament is a USBC sanctioned tournament and is open to all USBC sanctioned bowlers in good standing.
2. This Tournament is a "scholarship" Tournament. Scholarships will be awarded to at least top 4 teams. If there are sufficient scholarship funds available, additional scholarships will be awarded in each division. The USBC SMART program will administer the scholarships. Teams can be all boy all girl or mixed.
3. The tournament will start at 2:00PM Sunday April 18, 2010 when teams will bowl eight (8) games of qualifying across 4 pairs of lanes. Each game will be contested on the same lane throughout all 10 frames. Bowler 1 will bowl odd frames bowler 2 will bowl even frames. Following game 1, teams will alternate lanes, at the completion of game 2, teams will move one pair to the right and follow same format. At the conclusion of the qualifying round the top 8 teams will be placed in a bracket format. 1v8, 2v7, Etc. in a best of 3 game match play until winner is decided. In the event of a tie a 9th and 10th frame roll off will be used to determine advancing team. If a tie still exists the 9th and 10th frame roll off will repeat until tie is broken.
4. Bowlers must check in at least 45 minutes prior to the start of the tournament for lane assignments and present their 2009-2010 USBC sanction card.
5. Any bowler who arrives after the start time of the tournament will begin in the current frame in progress and will receive a (0) zero points for all frames not bowled. Late bowlers will not be permitted to practice.
6. Bowlers must be ready to bowl when it is his/her turn or receive a zero for that frame.
7. Entries must be legible with all information filled in and all necessary.
8. There will be **NO REFUNDS** after entry has been processed.
9. Appeals and protests – see Rule 329 in the USBC rules book.
10. Only bowlers and tournament officials will be permitted in the bowling area.
11. Eating and/or drinking in the bowling area are not permitted. Bowlers will not be permitted to smoke or use any form of tobacco during the tournament.
12. The tournament officials reserve all rights
13. Bowlers are required to wear "proper attire" when bowling in the tournament. Ripped or tattered clothing, shorts, shirts with obscene languages or gestures, hats of any kind, are not considered proper attire and shall not be worn.
14. Bowlers must behave in accordance with the rules of good sportsmanship. Gum chewing, foul, abusive and obscene language or gestures, and mistreatment of equipment will not be tolerated. Violation of this or any other rules carries a penalty of disqualification from this tournament.
15. ALL INFORMATION IS SUBJECT TO VERIFICATION.
16. The tournament officials will strictly enforce all the above rules of the USBC.
17. There will be a break between the qualifying round and the match play finals, for verifications and placements of the teams for match. Winners will be announced after the completion of play and after all scores are verified.

Entries are limited to the first 64 teams.
